**2008-2009 FINANCIAL POLICY & RELEASE AGREEMENT**

Our mission is to provide you with Quality Dance & Floor Gymnastics Education in the most productive and positive environment possible. Please assist us in making this possible.  
This must be completed to participate in our school.

**PAYMENT POLICY:**

**Statements**-Our statements are a courtesy to you. They are sent out via snail mail, email, and/or in class on or about the 24<sup>th</sup> of each month. Statements are handed out in class when an account is 10 days past due. This is an attempt to resolve any matters of concern.

**Types of Payment Accepted** – Check and cash. Visa & Mastercard.

**Registration Fee** – A \$50.00 registration fee is due with every registration form.

**Monthly Tuition** – Tuition amounts are flat rates based on an average of four lessons a month. We run on a ten month year. Missed classes may be made up, however there will be *No Discounts, Prorated Or Waived Tuition* for missed classes. All tuition is prepaid for the upcoming month and is due on the 25<sup>th</sup> of the preceding month. Tuition received in our office after the 1<sup>st</sup> will be assessed a \$20.00 late fee. The exception is May and ½ of June’s tuition which is due April 25<sup>th</sup>. All Payments will be applied to the oldest outstanding item first.

**Past Due Payments:** A late fee will apply to any item past due. It is your responsibility to contact Mr. Michael in the office to resolve any issue that may come up. We do not carry amounts past due. When accounts are past due statements will be handed out in class. Non-payment of past due amounts will resort in class suspension until paid in full.

**Optional payment plans include:**

\*BI-ANNUALLY (5 months) – paid by August 16<sup>th</sup> and again by January 5<sup>th</sup> receive a 5% discount.

\*ANNUALLY (10 months) – paid by August 16<sup>th</sup> receive 10% discount.

\*AUTOMATIC CREDIT CARD PAYMENT – With the use of Visa or Mastercard- tuition, recital fees, etc, can be automatically charged on or about the 16<sup>th</sup> of each month once the authorization form is completed and returned to the office.

**Recital Fees** – These fees are due in two installments. The first is due on November 1<sup>st</sup> and is based on the number of classes your child takes per week. See below:

\*For students who take 1 hour or less of class, your 1<sup>st</sup> installment is \$80.00.

\*For students who take 1 hour 15 minutes of class, your 1<sup>st</sup> installment is \$100.00.

\*For students who take 1 hour 30 minutes of class, your 1<sup>st</sup> installment is \$150.00.

\*For students who take 1 hour 45 minutes to 2 hours of class, your 1<sup>st</sup> installment is \$175.00.

\*For students who take 2 ½ hours of class, your 1<sup>st</sup> installment is \$200.00.

The second installment is the balance of your recital bill and is due February 2<sup>nd</sup>.

Past due recital fees will be charged a 10% late fee.

**Competition Fees & Installments** – These fees are due according to your signed competition agreement. ALL Fancy Feet late fees apply to payments received after stated due dates.

**Returned Check Charge** – All returned checks will be charged a \$20.00 NSF Returned Check Fee and must be paid by cash or certified check. Late payment fee may apply. We cannot accept checks as payment after two or more returned check fees. (Late fee is determined on the date received- not the date of the check).

**Discontinuation of classes** – Our Policy is that you must submit a 30 day written notice for discontinuation of classes. If notice is not given, you will be responsible for the amounts charged.

**FANCY FEET DOES NOT GIVE REFUNDS! This includes but not limited to, Tuition, Registration Fee, Costume Installments, Competition Fees, etc.**

**\*Financial Policy & Release Agreement must be signed by Parent/Legal Guardian in order to be processed into the school.**
